

***iePoint* > 2015 Coming Soon**

It is almost that time of year again! Fall is fast approaching and so is the new version of *iePoint* > for the 2014-2015 school year. We are currently working to develop *iePoint* > 2015 and it will be released next week. The installation of *iePoint* > 2015 will separate the data years and create the *iePoint* > 2015 icon.

When *iePoint* > 2015 is released to your site, you will automatically receive notification upon entering *iePoint* > 2014.1.4 that an update is available.

SPP Indicator 13 Transition Data Error in *iePoint* > 2015

Once you have completed the installation of *iePoint* > 2015.1.0 the previous *SPP Indicator 13* warning “Independent Living transition data is incomplete” will now be an **ERROR** “Transition data is missing for Indicator 13”. The missing Independent Living information must be completed in order to transmit on the first required transmission of October 10th.

Be sure to *Refresh Common Data* and *Check Data Validity* after completing the installation of *iePoint* > 2015.1.0 in order to have the most up to date information.
