There are 3 working days to complete the Child Count Certification. If your district superintendent has not completed this step, be sure to contact them today!

Per the recent ISBE Memo: 'If district administrator certification is not complete by March 27, distribution of IDEA Part B grant funds will be suspended until the certification is complete.'

Coming Soon - New and Improved Claims Training !

Don't miss out on the new and improved claims training sessions! Claims sessions will begin in April and continue through August.

The *Claims Updates and Preparation* will be a "pre-game" of the changes for this years claims - the most important being due date changes. We highly recommend that you plan on attending this session!

The claims sessions will no longer cover all fund codes and the *Personnel Approval* information. Each session will be based on a specific fund code or the *Personnel Approval*. When registering for a claims training, simply select the session based on the type of claim you need to complete. For example, if you are responsible for the private facility claim, you should register for the Fund B (Private Facility) session.

At Harrisburg Project, we are always striving to provide the best learning environment for our clients. We know that your time is valuable and that not everyone has the ability to attend a 2-3 hour claim training. We hope the shorter fund code specific sessions will allow more clients to attend and receive the necessary information in order to complete the claim in a timely and accurate manner.
