## Sp Ed DCFS Youth-in-Care Verification

The deadline to have Youth-in-Care (YIC) students that were enrolled in the district and receiving special education on or before March 1<sup>st</sup> is Wednesday, May 15<sup>th</sup>.

ISBE has provided a list of possible YIC students to each district. This list is updated on a weekly basis! Please check this weekly to be sure you have not missed a student that should be coded as Fund E or F in I-Star. To view the instructions to view possible YIC students, click the following link:

Remember, if a YIC student enters your district for special education services after March 1<sup>st</sup>, you still need to enter a Fund E or F *Student Approval* record into I-Star! This will allow you to submit a *Student Claim* on July 15<sup>th</sup>. These student are reimbursed at 100% so it is very important that all students are entered into I-Star.

## SPP Indicator 14 - Now Open!

Each year ISBE is required to collect Indicator 14 of the State Performance Plan (SPP) on post-school education/training and employment for youth with Individualized Education Programs (IEPs) one year after leaving High School.

A portion of the school districts have been selected and should have received formal notification from ISBE. To see if your district is included in this years SPP Indicator 14 data collection, click the following link:
