Personnel Approval Due Date Change

The due date for *Personnel Approval* records has been changed to Friday, June 28, 2019. This information was previously collected in August. Please be sure that staff members working with the Personnel Approval data elements in I-Star are aware of this date change.

All staff members working with Special Education students should have an approved Personnel Approval record by the end of the day, June 28th.

The salary information is **not needed** by this date. Salary information will only be entered for staff members to calculate the student claim for Funds D, E, F, X, or J.

Annual Review Report in I-Star

I-Star is an excellent place to track the Annual Review date for a student receiving special education. If your cooperative or district uses this feature in I-Star, the 'Annual Review in Date Order' report can be used to be sure that a student's annual review date is not missed.

To run this report, click the Report Tab in the top toolbar, then selecting Report Type: Student -> Report Categories: Event.

The 'Annual Review in Date Order' will show the Annual Review Date, as well as the Re-Eval date if entered.
