Student Claims - Fund Codes D, E, F, X, J DUE TODAY!!

ISBE will collect the *Student Claim* records today for Fund Codes D, E, F, X, and J. In order for these records to be picked up, they must be error free!

Run the Student -> Errors -> Student Claim Errors by Resident District and Serving School report from the Report Tab in I-Star. (Fund Codes D, E, F, X, J are included in the July 15th Student Claim pickup)

Visit the Claims tab for students with errors. Make sure that days enrolled, days in session and all costs are entered. If a claim will not be submitted, uncheck the 'Include in Claim' checkbox.

Once you have completed the *Student Claim* records, be sure to print the following reports from the Report Tab: *Student -> Reimbursement/Claim in I-Star:*

'Student Reimbursement Funds DEF Regular Term'

'Student Reimbursement Funds X and J'

These reports should be printed and maintained for future audit purposes.

Limited Data Entry Starting July 16th

Once ISBE collects the *Student Approval* records and the *Student Claim* records for Fund Codes D, E, F, X, and J on July 15th, data entry will be limited.

Starting Tuesday, July 16th the following limitations will be in place:

- All *Student Approval* records will be locked for editing (except Fund B). No new *Student Approval* records or *End/Adds* will be allowed even with a begin date after August 1st until the 2019-2020 school year is opened by ISBE.
- Student Claim records for Fund Codes D, E, F, X, J will be open for editing. This will be a 'data correction' period through Wednesday, July 31st. Editing is allowed on existing claim records only!
- Personnel Approval records are open for editing the salary and benefits section through
 July 31st. No new Personnel Approval records are allowed until the 2019-2020 school year
 is opened by ISBE.
