Fund B Student Claim Data Correction Closes Sept. 30th

The Fund B *Student Claim* data correction period will close at the end of business, Monday September 30th. After this date, all Fund B *Student Claim* records will be locked and no further edits will be allowed.

Remember, the *Ed Cost per Pupil* entered on the *Student Claim* record should include the Regular and Summer term charges!

Exit Data Collection Due September 30th

ISBE will collect *Student Approval Exit Data* at the end of business, Monday September 30th.

Exit Data is required for any student that didn't return to special education in your district for the 2019-2020 school year. Before I-Star allows a record to be deleted, the *End Date* and *Exit Code* must be entered in the box at the bottom of the record. The *Exit Code* 20 is not a valid *Reason for Exit* when a student is not receiving special education services this school year.

We recommend running the 'Exit Data Error Report' prior to September 30th. To run this report in I-Star, select the Report tab and select Report Type - Student; Report Categories - Errors; Change the School Year to 2018-2019 in Report Filters. Dates to Remember

September 30, 2019 - Fund B Student Claim Data Correction Closes

September 30, 2019 - 2018-2019 Exit Data Pick Up

October 14, 2019 - Office Closed in Observance of Columbus Day

November 1, 2019 - Summer Term Orphanage (Funds DEF) Student Claim Data Pickup
