Sp Ed Youth-In-Care Verification Deadline is May 15th

Have you reviewed the possible Youth-in-Care (YIC) report for your district? If not, you could be missing out on valuable funding for your district! This is VERY IMPORTANT! By failing to review the possible YIC students for your district, you could be missing out on 100% funding for the education your district provides to YIC students.

The deadline to submit YIC students (Fund Codes E or F) in I-Star, with a begin date of March 1st or prior, is Friday May 15th! These students will be eligible for 100% reimbursement on the June 15th Regular Term Orphanage Claim.

Any YIC student (Fund Codes E or F) with a begin date of March $1^{\rm st}$ or prior NOT entered by the May $15^{\rm th}$ deadline WILL NOT be eligible for 100% reimbursement! These students will be included in the EBF enrollment calculation, however your district will lose the 100% reimbursement available for these students.

Don't let your district miss out on the funding it is eligible to receive. Take the time to review the possible YIC report by following the instructions at the following link:

If you do not have access to the above report in IWAS, the Possible YIC tab in I-Star will provide you with the same information. Simply select Approvals and Claims -> Student -> Approvals-> Possible YIC:
