Summer 2021 Fund Codes DEF Claims Due Today!

Summer 2021 Orphanage claims (Fund Codes DEF) will be picked up at the end of business today Monday, November 1st, per statute. All districts that reported Orphanage Students (Fund Codes DEF) attending summer school following the end of the 2020-21 school year are required to complete a claim in order to receive reimbursement. Summer 2021 Special Education Orphanage Claims Due Nov. 1

Student Claim records created by November 1st will be in Data Correction November 2nd-15th. Student Approval records will be locked, no further edits will be allowed.

The Summer 2021 Orphanage Claim data is entered into the 2020-2021 school year in I-Star. Be sure to change the school year to 2020-2021 (the screen is Salmon colored) before entering claim data.

ISBE will collect the FINAL 2020-2021 *Room and Board Claims* at the end of business today, Monday November 1st. All claims and adjustments must be entered into I-Star under *Approval and Claims* -> *Student Residential Claims*. This data pickup is for any student that had a *34-37 Residential Approval*.

The time frame for this claims submission is September 1, 2020 - August 31, 2021. Any outstanding claim or adjustment not entered by the November 1st deadline will forfeit reimbursement.
