Dates to Remember

February 23, 2022 - FINAL December 1 Child Count

February 24, 2022 - Springfield IAASE

February 24, 2022 - March 10, 2022 - Student Approval Data Locked, Read Only Access

March 11, 2022 - March 25, 2022 - Child Count Certification Completed by District Superintendent

FINAL December 1 Child Count - Wednesday, Feb. 23rd

This is it! The FINAL December 1 Child Count will be picked up at the end of business Wednesday, February 23rd. Effective Thursday, February 24th the *Student Approval* data will be locked for editing. You will have read-only access.

The district superintendent will certify the final data collection number. Be sure the data is accurate by reviewing the following information in I-Star:

- Report type *Student* -> Report Categories *Approvals* -> *Child Count Snapshot by Resident District*. (This report will not change when corrections are made to the data. It will show the preliminary data picked up on February 18th.)
- *Current Child Count Status* found on the landing page of I-Star. This information will give you a count of approved *Student Approval* records for all fund codes (except N & U) that are checked to 'Include in Approval' and active on 12/1).

In an effort to assist districts and cooperatives with reporting an accurate December 1 Child Count number, error emails and courtesy calls will be made to locations with remaining *Student Approval* errors.



DCFS Eligibility Errors

ISBE has not received the January DCFS eligibility file. If you have DCFS verification errors in I-Star because of this, do not contact ISBE for corrections. The records will be approved by ISBE staff during the I-Star lockout.

Final 2020-21 IDEA Room and Board Claim Payment Information

The 2020-21 Individuals with Disabilities Act (IDEA) Room and Board program (Revenue code 4625) is now complete. All claims were reimbursed at 100 percent!

The 2021-22 Room and Board claims should be submitted on a monthly basis. These claims will be paid at 75 percent during the 2021-22 school year. Final claims and proration will be calculated and paid after all claims are finalized in the fall of 2022.
