### FACTS & Personnel Approval Due March 8<sup>th</sup>

The next required *FACTS* and *Personnel Approval* Transmissions are due Friday, March 8, 2013. Permissions are on so don't wait; send your file once it is error free!

You may transmit as many times as necessary until the end of business on Friday, March 8<sup>th</sup>. If you are a member of a Super Site, your Super Site may have designated an earlier due date.

### Claims Trainings

Harrisburg Project is hosting 3 classroom claims trainings this spring. 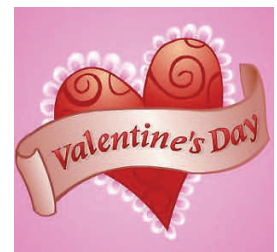
