

### ***iePoint* > 2015.1.1 Reports Release: Reports for IDEA Excess Cost Worksheet**

The Illinois State Board of Education's IDEA grant team has developed a method, beyond written assurances, to document that all districts determine their IDEA excess cost threshold and expend that amount of local fund on services for students with disabilities. All IDEA excess cost forms, instructions and technical assistance items (tip sheet, video, webinar, powerpoint slides with speaker notes) are available on the IDEA grant webpage at [http://www.isbe.net/spec-ed/html/idea\\_part-b.htm](http://www.isbe.net/spec-ed/html/idea_part-b.htm).

The completion of the IDEA excess cost worksheet requires the December 2014 child count for the 2014-2015 school year for students in grade levels KG-8 and 9-12. *iePoint* > 2015.1.1 Reports Release will assist in this requirement.
