# 2016-2017 Exit Data Deadline Today - October 16th

The deadline to enter the End Date and Exit Code for the students that are not receiving services in the 2017-2018 school year is today, October 16<sup>th</sup>. This data will be pickup at the end of business by ISBE.

To determine what students require this information to be entered, run the 'Students Missing Exit Data' report by selecting *Student -> Errors* and change the school year to 2016-2017 in the Report Filters. ## **Reason for Exit Code 20**

The only time *Exit Code* 20 should be used is when a *End/Add* is completed in I-Star. The *Exit Code* of 20 was created for the purpose of showing ISBE a 'change' was being made to the following information:

- Change of Fund Code
- Change of Services ie: Serving Location, Related Service, EE Code This is not an acceptable reason for exit at the end of a school year.
