2019 End Dates in SIS

SIS requires that all 2019 student enrollment records are exited by 4:00 PM July 31, 2019. The exit date should be the last FULL day the student was scheduled to receive educational services, regardless of whether the student was in attendance or absent that day.

However, if you have students taking summer classes, please wait to exit those students until after they finish their classes.

Final Public School Calendar via IWAS

If the approved public school calendar DOES NOT include emergency days taken this school year, now is the time to follow up with the district superintendent to be sure the FINAL public school calendar has been submitted via IWAS.

- May 15, 2019 DCFS YIC receiving Special Education must have approved Fund E or F Student Approval record in I-Star
- June 28, 2019 Personnel Approval data pickup
- July 15, 2019 Fund X and J (Regular & Summer Term) Student
 Claim data pickup
 Orphanage Fund D, E and F (Regular Term) Student Claim pickup

Dates to Remember

May 15, 2019 - Deadline for Orphanage Student Approval in I-Star

May 27, 2019 - Office Closed in Observance of Memorial Day

June 28, 2019 - Personnel Approval Due in I-Star

July 4-5, 2019 - Office Closed in Observance of 4th of July

July 15, 2019 - Excess Cost (Fund X, J) Student Claim Due in I-Star and Orphanage (Fund DEF) Regular Term Student Claim Due in I-Star

Special Transportation - Related Service 25

Districts that provide special transportation based on a student's IEP can claim for reimbursement on Fund Codes E and X. Be sure to include Related Service of 25 on the *Student Approval* record for those students receiving this service.

- Fund E Student Claim record should include 100% of special transportation charges.
- Fund X Student Claim record should include 20% of special transportation charges.

The amount for special transportation claimed in I-Star for Fund E or X SHOULD NOT be included in the district transportation claim submitted via IWAS.
