To delete an approval record, follow the instructions in the <u>I-Star User Guide</u> by selecting Personnel User Guide-> Editing/Deleting Personnel Approval Record.

June 30, 2020 - Personnel Approval Data Due

## Sp Ed Youth-In-Care Verification Now Available

The Evidence Based Funding (EBF) student count must account for and deduct the Department of Children and Family Services (DCFS) Youth-in-Care students (YIC) (Fund E or F) since districts are reimbursed for 100% of their educational needs.

ISBE is requiring that ALL YIC students (Fund E or F) with a begin date prior to March 1<sup>st</sup> be reported in I-Star by the end of business, May 15<sup>th</sup>. Students submitted by this deadline will be claimable in the Special Education Orphanage Student Reimbursement claim due on June 15<sup>th</sup>.

Students with a begin date prior to March 1<sup>st</sup> and not reported by the May 15<sup>th</sup> deadline WILL NOT be claimable in the June 15<sup>th</sup> claim, however they will be included in the EBF student count.
