Student Claims Data Correction to Close on Friday

The deadline to edit *Student Claims* for the following Fund Codes is 4:00 PM on Friday, July 31st:

- Orphanage (Regular Term) Funds D, E and F
- Excess Cost (Regular Term) Funds X and J

ISBE will lock the above *Student Claims* records once this data is collected; no additional edits will be allowed.

Student Approval Data Correction to Close on Friday

The deadline to edit *Student Approvals* for Fund Codes A, K, L, P, N, U, X and J is 4:00 PM on Friday, July 31st:

Student Reimbursement Reports to Print

The final step to the *Student Claims* process is to print the Student Reimbursement reports for Fund Codes D, E, F & X and J. These reports should be printed from I-Star and maintained for audit purposes.

ISBE to Complete Start New Year; Mass Change Available

ISBE will complete *Start New Year* in I-Star beginning on August 1st. This process requires exclusive access, therefore I-Star will be offline beginning Friday, July 31st at 4:00 PM until 7:00 AM Monday, August 3rd.

On Monday when you open I-Star the default school year will be 2020-2021. The *Mass Change* step of *Star New Year* will then be available. Prior to completing *Mass Change*, be sure to print the instructions from the following link:
