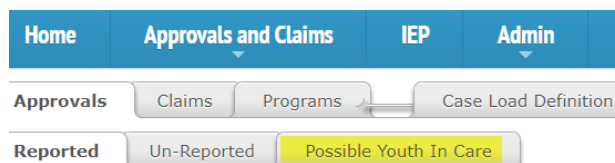
Sp Ed Youth-in-Care Verification Deadline - May 17th

Evidence-Based Funding (EBF) enrollment calculations must account for and deduct Department of Children and Family Services (DCFS) Youth-in-Care (YIC) who are reported in I-Star under Fund Codes E and F. Districts receive full state funding for these students through a separate claim.

ISBE is requiring that ALL YIC students (Fund E or F) with a begin date of March 1st or prior be reported in I-Star by the end of business, May 17th. Students submitted by this deadline will be claimable in the Special Education Orphanage Student Reimbursement claim due on June 15, 2021.

Students with a begin date of March 1st or prior and not reported by the May 17th deadline WILL NOT BE CLAIMABLE in the June 15th Special Education Orphanage Student Claim, however they will be included in the districts EBF student count.

In an effort to assist districts report accurate data, Harrisburg Project will continue to email districts on a weekly basis a list of possible YIC students miscoded in I-Star. The same list of students can be viewed in the 'Possible YIC' tab in I-Star, as pictured below:



These students may be either general education or special education. If the student is special education and they are on this list, then they are currently not listed in the I-Star special education data collection system as an orphanage student (i.e. Fund Code E or F) or, they are in I-Star, but miscoded as not being an orphanage student (i.e. Fund A, X or B). Any regular education student can be disregarded. If this tab is blank for your district, all students are being correctly reported as Fund E or F.

Dates to Remember

May 17, 2021 - Data collected for Fund Codes D, E, F with begin date of 3/1/2021 or prior.

May 31, 2021 - Office Closed in Observance of Memorial Day

June 15, 2021 - Fund Codes D, E, F Student Approvals/Claims Due

June 16, 2021 - Fund Codes D, E, F Student Approvals/Claims Correction Period Open

SPP Indicator 14 - Now Open!

Each year ISBE is required to collect Indicator 14 of the State Performance Plan (SPP) on post-school education/training and employment for youth with Individualized Education Programs (IEPs) one year after leaving High School.
