NEW! Public Acts 102-0172 & 102-0173

Public Act 102-0172

- Amended the school code to allow students that turn 22 during the regular term school year to continue services through the end of the year
- If the student is Fund Code A, D, E, F, H, K, L, P or B before turning 22, it is possible that no change will occur in I-Star on the 22nd birthday
- If the student is <u>NOT</u> Fund Code A, D, E, F, H, K, L, P or B before turning 22, an end/add needs to be performed in I-Star with a Fund Code A record beginning on the student's 22nd birthday

Public Act 102-0173

- If a student with an IEP reaches the age of 22 during the time in which the student's in-person instruction, services, or activities are suspended for a period of three months or more during the school year as a result of the COVID-19 pandemic, the student is eligible for such services up to the end of the regular 2021-22 school year.
- This Section does not apply to any student who is no longer a resident of the school district that was responsible for the student's IEP at the time the student reached the student's 22nd birthday.
- The IEP goals in effect when the student reached the student's 22nd birthday shall be resumed unless there is an agreement that the goals should be revised to appropriately meet the student's current transition needs.
- If a student was in a private therapeutic day or residential program when the student reached the student's 22nd birthday, the school district is not required to resume that program if the student has aged out of the program or the funding for supporting the student's placement in the facility is no longer available.
- Within 30 days after the effective date of this amendatory Act of the 102nd General Assembly, each school district shall provide notification of the availability of services under this Section to each student covered by this Section by regular mail sent to the last known address of the student or the student's parent or guardian.

Public Act 102-0172

- Applies only to students that turn 22 during this or future school years
- Long-term legislation
- Students will be Fund Code A, D, E, F, K, H, L, P and/or B* in I-Star
 <u>B* Fund</u> Code B <u>tuition</u> records allowed for Fund B past age 22 for in-state day school placements IF the facility allows placements past age 22.
- Applies to students that turned 22 during the 20-21 or 19-20 school year only

Public Act 102-0173

- Temporary Legislation
- Students will be Fund Code R in I-Star
