Fund Codes DEF Student Claims Correction - Summer

Today is the FINAL day to edit Fund Codes DEF *Student Claims* records for summer term. ISBE will collect this data at the end of business today, Monday November 15th. No further edits will be allowed after the data is collected and locked.

New! Fund R - Section 14-7.02 Postsecondary Transition Recovery Eligible

For school year 2021-22 only, students who return per Public Act 102-0173 for recovery services will utilize Fund Code R. If a student with an IEP reaches the age of 22 during the time in which the student's in-person instruction, services, or activities are suspended for a period of three months or more during the school year as a result of the COVID-19 pandemic, the student is eligible for such services up to the end of the regular 2021-22 school year. The suspended service period could have occurred in school years 2019-20 or 2020-21.

The complete Fund Code R description can be located on page 13 in the <u>Students</u> with <u>Disabilities Data Collection and Approval Instructions</u>. For additional guidance, see the <u>Frequently Asked Questions</u> document provided by ISBE.



New Field on I-Star Approvals - Unable to Locate Residential Placement

This field should be completed when an IEP team determines that a student requires placement in a private residential facility, but the district has not been able to locate a facility to accept the student. If the no placement is located, check the box. In the text box, describe the reason why unable to place (e.g., no facility accepted student, parent would only sign a limited number of releases, etc.). Type the date of the IEP meeting where it was determined that an IEP placement was required.
